We value your privacy and are committed to protecting your data. This Privacy Policy outlines how we collect, use, and protect information related to your use of our Chrome extension.

1. Information We Collect

Our extension collects only the information necessary to provide its functionality. This includes:

- User Preferences: Bookmarked hadiths saved locally for quick access.
- Theme Settings: Light or dark mode preference stored locally.
- Search Queries: Book and hadith numbers entered by users for search purposes, processed locally.

No personal information, such as names, email addresses, or other identifiers, is collected.

2. How We Use the Collected Information

The collected data is used solely for the following purposes:

- Processing user searches to retrieve hadiths from the Sahih Bukhari collection.
- Saving user bookmarks locally for quick access to favorite hadiths.
- Storing theme preference (light/dark mode) for a consistent user experience.
- Enhancing the user experience through local data caching.

We do not sell, share, or use your information for any purposes beyond those stated above.

3. Data Storage

- Local Storage: User bookmarks, theme preferences, and settings are stored locally in your browser using Chrome's storage API.
- Offline Data: All hadith data (Tamil translations and Arabic text) is bundled within the extension and accessed locally. No remote servers are contacted.

We ensure all data is handled securely within your browser.

4. Third-Party Services

Our extension does not use any third-party services or APIs. All hadith content is stored locally within the extension package.

5. Host and Remote Code

Our extension does not require any host permissions or remote code. All functionality operates entirely offline within your browser.

6. Permissions

The extension requests the following permissions:

- Storage: To save user bookmarks and theme preference locally for persistent access across browsing sessions.

This permission is strictly limited to the extension's core functionality.

7. Security

We prioritize the security of your data by implementing:

- Secure local storage practices using Chrome's built-in storage API.
- No external network requests or data transmission.

8. User Rights

As a user, you have the right to:

- Access and Delete Data: Clear bookmarks and stored data through the extension or by removing the extension from your browser.
- Revoke Permissions: Revoke the extension's permissions at any time via your browser settings.

No personally identifiable information is collected, so no additional data requests are necessary.
